### Old Business

### Land Use

- Baker County
  - Boat Ramp, Shoals Park Still in the process of reconciling design bids with the grant budget
- Camden County
  - Blue Bridge Access no update
  - Temple Creek Landing waiting on DNR
  - Spaceport still held up in GA Supreme Court
  - Raydient Development no update
- Charlton County
  - Camp Pinckney Land Alexander Land has approved a 3 acre donation to the county and the county is currently drawing up a contract

## Water Quality

- Temple/Horsepen/Mallet Creek 319 (Phase 3) project is complete and a final report has been filed
- NPDES Permits— no new permits in GA
- Spanish Creek (Clay Branch project) currently in draft 2 of the scope of work and waiting on a response from EPD
- Septic Think Tank Follow Up (bacteria) Blackriver HOA may be willing to host us for a talk in late March
- E&S Spreadsheet (sediment) Camden county info is complete in the spreadsheet.
  Scott Brazell sent it to admin who will distribute it to other members to finish populating
- o GA EPD Comprehensive Nutrient Permitting Strategy (N,P) Tyler Parsons at EPD reported that a three person team has been tasked with the project. They're beginning with assessing N, P, and chlorophyll A in large lakes and then working upstream and downstream from those. They'll then move to medium sized lakes and so forth.

Eventually, estuaries will be assessed in the same way, but this will likely take years

## **New Business**

- Reissuance of General NPDES Permits Nos. GAR100001 and GAR100002 the committee will submit a comment that they "appreciate the consideration of interstate criteria"
- Twin pines comment period open Public comment for the Trail Ridge mine opened on January 19 for a 60 day period (March 20 deadline). Two virtual public meetings will be held on 2/21 and 2/23 at 6pm. Registration should be done soon, as space is limited. The committee approved using a draft letter written by Chip Campbell and edited by Merrill Varn to address some main concerns, including issues with water level monitoring (using the Moniak gage vs. McIhenny), aerosolized salts and timber growth, groundwater depletion in the Okefenokee and upper St Marys during drought periods, the possible need for future water discharge permits, plan alterations that could require a buffer variance from EPD, and other pertinent points from Dr. Rhett Jackson's report.
